

HILL CHILD CARE INFORMATION 2020-21

Hill Child Care provides quality after-school care for a limited number of Hill School students and is directed by campus administration. The daily program includes a snack, homework time for grades 1-5, arts & crafts, playground time, computer time and Friday movie. Parents' understanding and support of the following guidelines are essential for each child's successful participation in the program. You know your child best. Please consider that he/she will be with other children all day. Parents will be responsible for corrective action if a child consistently disregards the standards of behavior required for the safety and well being of all children. Consistent inappropriate behavior may indicate the child care program is not a profitable experience for that child. It would then be necessary for parents to make other arrangements for other after-school care.

TUITION

Tuition is \$300.00 per month, due on the 1st and late after the 5th day of the month for September through May. Tuition for August 2020 is \$100 and is due the first week of school.

Payments after the 5th accrue at a \$5.00 per day late charge. If your account is not current by the 6th, you will have to conference with campus administration.

Tuition can be paid in the Hill Office or online through School Cash Online. Make checks payable to "Hill Elementary School".

Registration fee of \$100.00 per student is non-refundable. A registration fee in the spring of 2020 will hold a place for your child for Fall 2020. There is **always** a waiting list for the program.

Child Care openings are for full time only. You may attend as needed, but must pay the full amount.

PICKUP

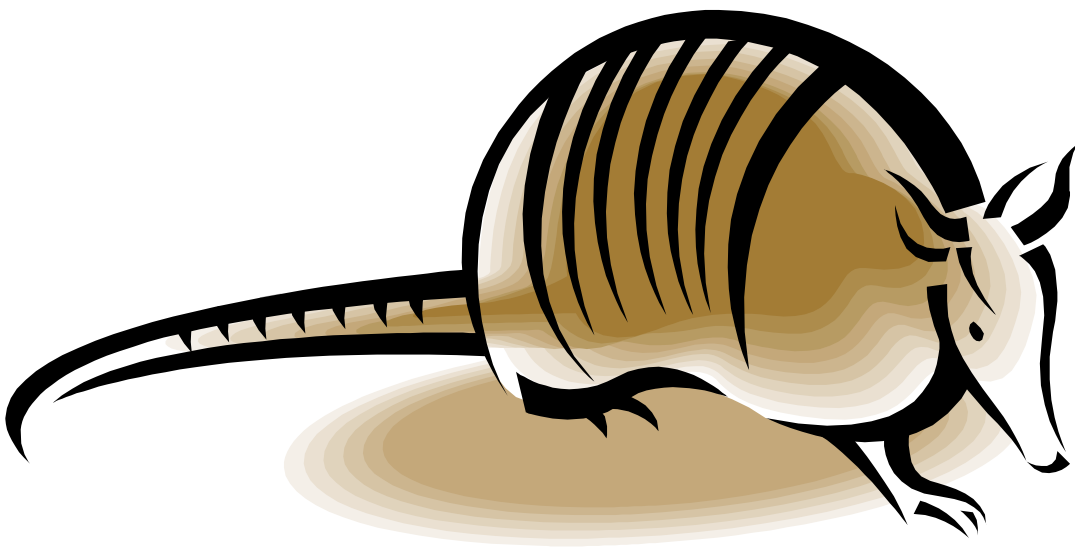
All children **must** be picked up **by 5:45 p.m.** Late pickup fees of \$10 plus \$1 per minute per child begins at 5:46PM. **Late Pickup fee due at time of pickup.**

Only those adults listed on the application form may pick up children. Photo identification may be required. Notify the Child Care Administrative Assistant at 512-414-4265 if someone not listed on the Application Form will pick up your child, and/or any changes in phone numbers or email addresses. Children may not leave Hill Child Care alone or with another minor unless prior arrangement by parent has been made through campus administration.
